- A chronological overview of your education and employment experience
- Copies of your education certificates geared towards working in childcare 1
- Copies of relevant grade transcripts or supplements to your certificates 1
- A copy of your passport or other identity document. A copy of your driving licence is not permitted.
- If you have one, a Certificate of Conduct (Verklaring omtrent het gedrag, VOG) for a position in childcare, issued within the past three months 2
- Optional: a document showing that you are eligible to work in childcare
- Optional: a copy of an IDW crendential evaluation, if you have one
- Optional: If you want to work in multilingual childcare you need to meet a language requirement. To prove this, you can send a copy of your diploma in higher education of which the programme was taught in English, German or French.

DUO may consult the responsible foreign authority for evaluation and verification purposes.

- 1 If these documents are not in Duch, English of German, you must enclose a sworn translation. This is translation made by a translator who has been certified in the Netherlands, or their home country, and which bears the translator's stamp.
- 2 If you do not currently hold a Certificate of Conduct, we may ask you to submit one at a later stage.
